## **INQUIRY ON WHETHER EXPORT CONTROLS APPLY TO A SPECIFIC ITEM**

In addition to the mandatory fields, you should also complete the fields necessary for classification. Fields marked in red are mandatory. You can only submit the inquiry in the e-services of the Ministry for Foreign Affairs.

### **Exporter**

Give the name and address of the exporter (incl. phone and fax number), Business ID (7+1 digits) and the exporter's web address (if available).

### **Description of the items**

Enter the product description, model and type number. Give the name normally used for the item for trading purposes. It must be possible to recognise the item unambiguously on the basis of the description.

### **Country of origin (if necessary)**

Select country and country code (such as United States US). Complete this field only if the item has been imported to the EU from a third country. If there is more than one description of the item, specify the part that this section applies to.

### **Commodity code (CN code) and CAS number**

Enter the commodity code with an accuracy of eight (8) digits (Combined Nomenclature/see TARIC). For chemicals/chemical mixtures, use the CAS number (Chemical Abstract Number).

### **In your own view, do export controls apply to the item? Reasons for your view**

Tick the 'Yes' or 'No' circle. If your answer is 'Yes', give also the classification number given in Annex I to the EU regulation 428/2009 on dual-use items. Give the reasons for your view.

### **Purpose of use**

Give the purpose of the item. You can also provide additional information concerning the inquiry.

### **Definition of defence materiel**

Tick the appropriate circle. If your answer is 'Yes', give also the classification number given in Annex I to the EU regulation 428/2009 on dual-use items.

### **Appendices**

Remember to append to the inquiry data sheets or other information that you consider essential. The data sheets are essential for ensuring the right classification.

### **Contact person**

Give the name, e-mail address, and phone number of the person in charge of the matter.

### **Inquiry submitted by**

Give your own name or the name of your authorised agent as well as the date. Katso identification in the e-services corresponds to an electronic signature. By signing the inquiry you also assure that the information on it is correct. If there are any changes to the information, you must submit a change application in the e-services of the Ministry for Foreign Affairs. Give your name, place and date.

Save the inquiry in your e-service account and submit it to the ministry.
