Q3) Regarding the consultancy contract we do not understand paragraph 14. Are we supposed to hire some Finnish personnel?

A3) There is no obligation to hire Finnish personnel. The consultancy contract is a generic version that will be modified case-specifically. Paragraph 14 will be valid only in case the Tender chosen by the Ministry includes employment of Finnish personnel.

A4) The Ministry does not impose any minimum requirements for the Junior Expert. The possible recruitment of the Junior Expert is the responsibility of the Tenderer. Please do, however, attach the CV of the Junior Expert to the Tender.
